

# Terms and Conditions: Finish Your Year Strong Health Check Competition

## Eligibility:

- 1.1 The 'Finish Your Year Strong Health Check Competition' (referred to as 'the Competition') is open to individuals who are eligible to access health-related services, as specified in the eligibility document. [TEM-01-PUB-Service-Eligibility-001-2.pdf](#).
- 1.3 The Competition is open to both current clients and those eligible to become clients.
- 1.4 Employees, representatives, or contractors of SCMSAC are not eligible to participate.

## Entry:

- 2.1 To enter the Competition, participants must attend a health check between 1st August and the 1st December, 2024.
- 2.2 Participation in the Competition is free of charge, and completion of a 715 Health Check, GP Management Plan, or a review of an existing plan is the sole requirement for entry. Clients who have recently undergone a health check and are not scheduled for a 715 health check or GPMP/Review may alternatively enter the Competition by completing a competition survey.

## Competition Period:

- 3.1 The Competition period is from August 1st, 2024 to December 1st, 2024.
- 3.2 Entries received after the closing date will not be considered.

## Prize:

- 4.1 A winner will be randomly selected fortnightly from each week's appointment list, beginning on the 14th August, 2024, with a total of 24 voucher winners.
- 4.2 Each winner will receive one \$50 voucher.
- 4.3 The prizes are non-transferable and cannot be exchanged for cash or any other alternatives.
- 4.4 The final prize, 3 x Healthy Hampers, will be drawn randomly on Tuesday the 2nd December, 2024, from all health check attendees during the competition dates, who have not won a \$50 voucher.

## Winner Notification and Prize Claim:

- 5.1 Winners will be notified via the contact details in our system within seven (7) days of the draw. Entrants are encouraged to ensure their contact details are up to date when attending their health check appointment.
- 5.2 Winners must respond to the notification and organise pick up from the Jane Ardler Centre, 51-53 Berry St Nowra, within fourteen (14) days of notification.

# Terms and Conditions: Finish the Year Strong Health Check Promotion for Bubs and Primary Schoolers

## Eligibility:

- 1.1 The 'Finish the Year Strong Health Check Promotion for Bubs and Primary-Schoolers' (referred to as 'the Promotion') is open to individuals who meet the following criteria:
- 1.2 Clients with babies (ages 0-2) are eligible for the baby bag promotion, and clients with pre-schoolers (ages 3-12) are eligible for the backpack promotion. Clients who receive a baby bag will automatically go in the draw to win 1 of 20 car seats suitable for ages 0-4.
- 1.3 Participants must be eligible to access health-related services as outlined in the document [TEM-01-PUB-Service-Eligibility-001-2.pdf](#).
- 1.4 The child's age and the completion of a 715 health check or a pre- or post-natal maternal health check for mother and baby are the sole requirements for eligibility. Clients who have recently undergone a health check and are not scheduled for a 715 health check can still participate in the voucher competition by completing a competition survey.

## Reward Distribution:

- 2.1 Eligible clients can earn rewards for each child who completes a 715 health check. For instance, if a client has two children, aged 2 and 5, and both complete their health checks, the client can receive both the baby bag and the backpack. The SCMSAC worker has the flexibility to adjust the age requirements if the family prefers a backpack over a baby bag for younger children.

## Verification of 715 Health Check:

- 3.1 The completion of a 715 health check or a pre- or post-natal maternal health check for mother and baby will be verified through information entered by the GP into our system.
- 3.2 Only health checks conducted during the promotion period will be considered for reward eligibility.

## Competition Period:

- 4.1 The Promotion will run from August 1st, 2024 to December 1st, 2024, or until stocks last.

## Prizes:

- 5.1 Clients with babies (ages 0-2) who complete a 715 health check or a pre- or post-natal maternal health check for mother and baby are eligible to receive a baby bag.
- 5.2 Clients with pre-schoolers (ages 3-12) who complete a 715 health check are eligible to receive a backpack.
- 5.3 Clients who have recently undergone a health check and are not due for a 715 health check may alternatively take part in the voucher Competition by completing a competition survey.
- 5.4 A winner will be randomly selected fortnightly from clients who receive a baby bag, beginning on the 14th August, 2024, with a total of 20 car seat winners.
- 5.5 Each winner will receive one car seat.
- 5.6 The prizes are non-transferable and cannot be exchanged for cash or any other alternatives.
